1. Water User Information
  - a. Name and Address – This information will be used to contact you regarding water system development and project progress. Please provide your mailing address, one or both telephone numbers and an email address if available.
  - b. We need to know if you are the owner of the property because some of the process for water system development, including district formation and easements, must be handled by the property owner.
2. Location of service
  - a. This information is used in system planning to determine where the water will be delivered. If the property address is the same as your mailing address you may insert "same as above". Please provide the actual water service property address if it is different from your mailing address.
  - b. The parcel ID/Tax ID is on your property tax bill on the upper left of the page. Fill in the final character of the blanks if your parcel ID ends in a letter. Leave the last space blank if your parcel ID does not end with a letter.
  - c. Some parcels will have more than one dwelling or building for water service. IF you desire more than one meter from the water system to service separate buildings, indicate the number here. This applies only to multiple locations on a single parcel. If the locations are on separate tax parcels, please complete a form for each.
  - d. If the water service is being requested for a non-household use, such as a shop building or an office, please indicate with a check mark.
  - e. If the location is a future home, on a parcel with no existing dwelling, please indicate with a check mark.
